Relief :

a. Direct the defendants to effect partition of the suit schedule proeprties into four equal shares by metes and bounds among the plaintiff and defendant No.1 to 12 and further put the plaintiff in separate possession of her legitimate 1/4th equal share. Failure to do so, this Honble court be pleased to effect the partition of the suit schedule proeprties and allot the plaintiffs 1/4th share through the process of law.

b. Declare that the sale deeds dt.09-08-2011, 02-02-2017 two sale deed dt. 04-12-2013, sale deeds dt.30-11-13, 07-12-2013 23-11-2013, 23-11-13, two sale deeds dt. 16-11-13, sale dees dt. 25-02-14-, 25-02-14, 07-03-14, 27-03-14, two sale deeds dt..19-04-14, SALE DEEDS DT.04-08-14, 01-10-14, 11-05-15, 04-06-15, 06-06-15, 11-06-15, two sale deed dt.20-06-15 sale deeds dt.23-05-15, 28-05-15, 03-06-16, 02-07-16, 02-07-16 and JDA dt.19-06-17 registered on 20-06-17 are sham, collusive and nominal documents and the same are not binding on the plaintiff to the extent of her 1/4th equal share in any manner.

c. Restrain the defendant No.13 to 57 from alienating or encumbering the suit schedule proeprties in favour of third parties in any manner and also to restrain the defendant No.16 to 22 from changing altering the nature of the suit schedule properties bearing sy. No.59/3, 72/1 and 78/1 either by themselves or by their GPA holders, agents, supporters, henchmen or any persons or persons claiming any right under or through them by granting permanent injunction.

d. Direct the defendants to pay the cost of the suit.

e. To grant such other reliefs and cost of the suit.
